This quotation is from Straitline Canvas Ltd. (also 'Straitline', 'Straitline Canvas', 'we', 'our', or 'us'), to the company or person named on the quotation, or any person acting as a representative of that company or person (also 'the customer', 'you', or 'your'). This quotation is subject to the following terms and conditions:

## General Terms

1. Unless otherwise stated, all prices quoted are exclusive of GST and freight.
2. Quotes are valid for 30 days from the date of quotation, unless otherwise stated.
3. Any quoted prices are only valid for the design, measurements, and quantity originally requested by you. Any changes to design, measurements, and/or quantity may incur extra charges, payable by you, unless re-quoted.
4. Please note that any 'rough price', 'idea of price', 'estimate', or similar term, given to you by a staff member of Straitline is not a quote unless specifically stated. We accept no responsibility for the accuracy of such estimates.
5. If we make a genuine error in a quote, we may amend or retract the quote. A quote cannot be retracted if you have accepted the quote and placed an order with us.
6. All intellectual property, including drawings, plans, patterns, designs, etc. created by Straitline in quoting or providing goods and services to you, shall be the exclusive property and copyright of Straitline, unless otherwise agreed to in writing.
7. Once you accept this quote, you will not be able to cancel production, or alter the design and/or quantity, once production has started. Production is deemed started once fabric has been cut or ordered, or once a repair or labour-only job has been started.
8. If it is expected that Straitline is to take measurements for manufacturing, then we reserve the right to change any quotation once final measurements are confirmed.
9. If any part of these terms becomes unenforceable for any reason, the agreement shall remain in full force except for the unenforceable part, which will be deemed deleted.
10. Force majeure: In the event that either party shall be delayed or prevented from carrying out all or any of its obligations and liabilities under this agreement as a result of any cause beyond its control including, but in no way limited to strikes, storm, fire or accident, it shall be relieved of all obligations and liabilities incurred under this agreement insofar and so long as the performance of such obligation is thereby prevented, frustrated, or impeded.
11. This agreement will be governed by and construed in accordance with the laws of New Zealand and the parties submit to the exclusive jurisdiction of the Courts of New Zealand.
