- Offsite work can continue
- Staff required to record sites they have visited
- Masks not required for staff
- All customer site requirements must be followed

**Standard Precautions**

In the event a staff member feels unwell, is showing symptoms consistent with Covid19, has recently returned from overseas, or has been in contact with a confirmed Covid19 case, they must get a Covid19 test and/or self-isolate in accordance with Ministry of Health advice and government regulations.

Staff are required to wash their hands with soap and water or hand sanitiser:

- When they arrive at work in the morning
- Before eating
- After returning from offsite

Staff must inform William Rice (021 925 891) as soon as possible if they have any of the following symptoms:

- High temperature (at least 38°C)
- Cough
- Sore throat
- Shortness of breath
